- If the Exhibitor refuses to participate before 6 March 2024, the Organizer reserves the right to withhold 50% of the cost of the Exhibitor's participation fee. If the Exhibitor refuses to participate after 6 March 2024, the amount received from the Exhibitor will not be refunded.
- Upon the confirmation of participation by the Expert Board, the Agreement shall be drawn up and signed by 17 April 2024. The certificate of acceptance of work (services) shall be drawn up and signed no later than 21 April 2024.
